## DDH1 Limited (ASX: DDH) – Admission and Commencement of Official Quotation

### Description

DDH1 Limited ('DDH') was admitted to the Official List of ASX Limited ('ASX') today, Monday, 8 March 2021.

Official quotation of DDH's ordinary fully paid shares will commence at 1:00 PM AEDT on Tuesday, 9 March 2021.

DDH raised \$150,000,000 pursuant to the offer under its prospectus dated 10 February 2021 ('Prospectus') by the issue of 136,363,636 shares at an issue price of \$1.10 per share.

A further 574,826 shares were issued to eligible employees pursuant to the Employee Concessional Offer.

DDH also issued 205,866,215 fully paid ordinary shares to existing holders ('Existing Holders') of DDH1 Holdings Pty Ltd as consideration for the acquisition by DDH1 Group Holdings Pty Ltd of all the issued capital of DDH1 Holdings Pty Ltd as contemplated by the sale agreements agreed between DDH and the Existing Holders.
